

Energy experts support call for Energy Bill Revolution

Energy experts today backed the call by the Energy Bill Revolution to use carbon tax revenue to make the UK's homes super energy efficient.

The University of Exeter, SSE, Consumer Focus and WWF, along with representatives from 20 other organisations, today published the results of a series of roundtables on UK energy policy. They called for energy demand to be the centrepiece of energy policy, not an afterthought to make decarbonisation easier.

The final communique of the roundtables concluded that the Government's draft Energy Bill and existing energy efficiency policies would in their current state, fail to deliver a secure, clean and affordable power sector for the UK and would result in the UK missing out on some key economic growth opportunities.

The group called for measures to reduce energy demand to be given the same status as measures that seek to support the construction of low-carbon generation. They also highlighted the need to use carbon revenue to make homes super energy efficient to help minimise consumer energy bills and bring an end to the blight of fuel poverty. This is precisely what the Energy Bill Revolution alliance is calling for and is the only permanent way to drive down energy bills and end fuel poverty.

From 2013 onwards, the Government will raise an average of £4 billion in carbon taxes every year from the European Emissions Trading Scheme and the Carbon Floor Price. This is enough to bring 9 out of 10 homes out of fuel poverty. It could quadruple carbon emissions savings compared to the Government's new energy efficiency policies, and create up to 200,000 more jobs – exactly what we need to support the UK's economic recovery.

Research for the Energy Bill Revolution has revealed that fuel poverty could affect 9.1 million households by 2016, the year in which the Government has a target to eliminate fuel poverty. This is a potential rise of 40% which would increase the number of UK households in fuel poverty from one in four to one in three.

Ed Matthew, Campaign Director of the Energy Bill Revolution said:

"An unstoppable alliance is emerging, calling on the Government to use carbon tax revenue to maximise household energy efficiency. If the Chancellor is genuinely concerned about household energy bills then he should hand back our carbon tax to make homes super-energy efficient. This is a just and fair solution to end fuel poverty and re-build Britain"
